Compliance with Law

The undersigned shall not use the premises or permit anything to be done in the premises which will conflict with any applicable local, state or federal law, ordinance, rule or regulation, as now existing or hereafter adopted or amended. This will include but not be limited to, illegal parking in fire zones, destruction of property (either City property or Private property surrounding City property), or public urination. Upon recognition of illegal activity, the rental will be immediately stopped and the rental group will forfeit all rental fees and damage deposit.

Insurance

Rentals that are open to the public, and where tickets are sold and alcohol is served will be required to provide at least \$1,000,000 combined single liability insurance policy naming the City of Federal Way as additional insured.

The City of Federal Way reserves the right to refuse to rent City facilities to any private group or organization based on previous performance of renter. I understand the regulations included in the Federal Way Community Center Rental Information are incorporated by reference into this Agreement and I agree to abide by the same.
